Dear Students:

Recently you should have received` a notification from us that you were eligible for student emergency funding related to the COVID-19 pandemic. Our institution was awarded \$1.6 million from the CARES Act in order to aid students who meet the eligibility criteria outlined in the original notice provided on Wednesday April 29th. To date, we have received over 300 completed applications. Applications are currently being processed and funds will be paid within two weeks for those who have completed the application and submitted their bank account information for direct deposit along with a voided check. Other applications that were submitted with bank information only or did not submit banking information at all, will take a little longer and generally these will be sent within 2-4 weeks either by deposit once validated or by paper check.

We encourage you if you are receiving this notice and have yet to apply, to go to your dashboard and complete the required application form and submit it electronically. We cannot act on this on your behalf until you do. The sooner you act, the quicker we can release the eligible funds to you.
