## Dear Students:

The Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) was passed by Congress and signed into law December 27, 2020, and is the second round of funding under the Higher Education Emergency Relief Fund (HEERF) during the coronavirus pandemic. The funding package provides aid to higher education students to cover components of cost of attendance and emergency costs associated with the coronavirus pandemic. PTC recently received a funding authorization to begin distributing funds.

In order to be eligible students must be actively enrolled or on an approved leave of absence at the time of completing the application. Funding will be prioritized to students demonstrating exceptional need based on PELL eligibility, FAFSA information and EFC (Expected Family Contribution). All students will receive at least \$300.00.

To make this application process as easy as possible for PTC students, a form will be added to your Dashboard for completion.
