From the Office of Student Financial Services

Dear Students:

The U.S. Department of Education has provided Emergency Financial support to students of our institution related to the disruption of campus operations due to the continued pandemic. The funding package provides additional aid to cover components of cost of attendance and emergency costs.

PLEASE NOTE: This is a completely new application as of August 2021 for additional funding over and above what you may have qualified for previously.

In order to be eligible as in the prior application, students must be actively enrolled or on an approved leave of absence at the time of completing the application. Funding will be prioritized to students demonstrating exceptional need based on PELL eligibility, FAFSA information and EFC (Expected Family Contribution). All students will receive at least \$1,000.00 in this round. <u>Please allow 2-3 weeks from the time of the processing of your application for funds to be distributed.</u>

To make this application process as easy as possible for PTC students, a form will be added to your Dashboard for completion.

If you or your family's financial situation has changed significantly from what is reflected on your federal income tax return (for example, if you've lost a job or otherwise experienced a reduction in income), you may be eligible to have your financial aid adjusted. FAFSA completion is required for this review. Please contact the Office of Student Financial Services to obtain the necessary forms or for more information at financialaid@ptcollege.edu or by contacting the school. Please note that the school's decision is final and cannot be appealed to the US Department of Education.
