## **Student Emergency Assistance for Campus Housing Students**

The U.S. Department of Education has made additional Emergency Financial support from HEERF funding available to students of our institution for their expenses related to the disruption of campus operations due to Coronavirus. **Dear PTC Housing Students:** 

The U.S. Department of Education has made additional Emergency Financial support to students of our institution related to the disruption of campus operations due to the continued pandemic. The funding package provides additional aid to cover components of cost of attendance and emergency costs. Campus Administration has determined that a portion of this funding can be used for housing.

As a newly enrolled student or a student moving back into housing for this October term, you are now eligible for this funding. Students must be actively enrolled and living in school sponsored housing at the time of the completion of the application and remain enrolled and in school housing at the time of the funding release. Funding will be in the amount of \$1000 for the October term only.

To make this application process as easy as possible for our PTC housing students, an application form has been added to your Dashboard for completion. The dashboard can be accessed by logging into <a href="www.myptcapp.com">www.myptcapp.com</a> It is important this is done ASAP in order to meet the requirements.
